PRESIDENT'S MESSAGE



I would like to open the April 2010 Border Bulletin by expressing my continuing appreciation for the incredible efforts demonstrated across your El Paso Chapter as we investigate new strategies procedures designed and increase membership and improve accountability. **Board** members have had some very constructive dialogue during our Saturday brainstorming sessions.

I continue to be impressed with the cooperative nature of the dialogue and the unified efforts to embrace change as we set the conditions to accommodate the impending surge of service and family members arriving to Ft Bliss this summer and early Fall. These truly are exciting times for our El Paso Chapter.

One of our Chapter's most important responsibilities is to continue to inform and influence the processes and policies of our higher MOAA echelons. Special thanks go to Ed Stone and Bill Moore for their efforts as participants in the recent Texas Council of Chapters meeting in Tyler, Texas. As most of you know by now, Ed Stone assumed the role as President of the Texas Council of Chapters during that meeting. Ed played a significant role in getting some key issues on the agenda of the recent Texas Council of Chapters meeting. Specifically, we have begun lobbying Regional and National levels to review their methods of accounting for memberships as well as informing both echelons of El Paso Chapter initiatives to transition to online registration processes utilizing online credit card processing. Bill Moore has taken the web site to another level and continues to investigate different processes that will facilitate easier registration and better accountability of membership. We think this will ease both membership application procedures and registration for different MOAA events. Additionally, we believe this will facilitate improved accountability efforts when the local chapter attempts to distinguish between local and national chapter memberships. We'd like to continue to encourage a more collaborative relationship between the local Chapters and Regional and National levels.

On 25 March, Colonel Joe Simonelli returns from Iraq and will assume command of the Ft Bliss Garrison. COL Simonelli is also a member of the MOAA National board and will bring tremendous perspective as the El Paso Chapter continues to contemplate initiatives focused on cultivating a larger following among the active duty and recently retired demographics here in El Paso. As we enter the third Quarter of FY 2010, our El Paso Chapter is in a unique position to influence policy and procedures at each echelon of the MOAA organization. The message is clear, it is increasingly important that all members of the El Paso Chapter reach out to fellow service members and recent retirees and gain their membership and more importantly, their perspective, as we shape our Chapter messages and themes, and continue to inform National policy. Expect an exciting year ahead, I promise.

Our El Paso Chapter has also initiated dialogue with the National level to host the 2011 MOAA National Convention right here in El Paso, Texas. I think the home of the largest Army installation in the Military would serve as a suitable host location for a National level MOAA Convention, and I think the unique partnership relationship Ft Bliss shares with the El Paso community serves as the perfect setting for the event. Will keep you all informed as we continue in dialogue to make this special event become a reality.

The El Paso Chapter continues to make progress to partner with and supports Active Duty and Family members within the Ft Bliss community. We have initiated an effort to feature the outstanding performance of junior grade officers in our Border Bulletin and will continue to feature these junior officers in each of our subsequent publications. We continue to receive tremendous feedback from 4th Brigade Combat Team, 1st Armored Division forward deployed in Iraq. The El Paso Chapter has also sponsored two teams participating in the Bataan Death March competition held annually at White Sands Missile Range. This year's competition will be held on 21 March at WSMR and the two teams we are sponsoring are the Joint Task Force-North All Female team, and the 2nd Battalion 43rd Air Defense Artillery team. Congratulations to both units and best of luck in the competition. Ed and Judy Stone joined Elma Rodriguez and I in welcoming home the great Soldiers of 3/3 CRAM, 11th ADA Brigade. We were all available to send off the equally great Soldiers of 3-43 ADA as they begin their tour of duty in Kuwait and Qatar. Your El Paso Chapter also continues to dispense scholarships to deserving young El Pasoans as we did with11 recipients in 2009. Refer to our website for additional information.

On the 20th of March, the El Paso Chapter will hold its annual Day at the Races at Sunland Park Racetrack. Currently there are more than eighty personnel registered to attend. The Chapter will also host more than a dozen Wounded Warriors at this event. It should also be noted that the next El Paso Chapter MOAA Luncheon will be held on 10 April at Landry's. The Board has decided to rotate locations for these Luncheons in order to entertain different venues around the El Paso area. During the 10 April Luncheon there will be a vote to amend several Bylaw paragraphs and to delete Section 6 of Article VI. These recommended changes reflect our Chapter's efforts to review and update By Law verbiage, and I think that is appropriate.

On a final note, the Chapter Board will begin holding its monthly meetings on the first Saturday of the month starting on 3 April, in Building 452. We will continue to hold our Saturday morning Brainstorming sessions each Saturday morning in Building 452 for anyone who wants to attend. 



Personal Affairs

As many of you know, changes numerous are transpiring at Fort construction Bliss, is at an all time high throughout Fort Bliss and East Bliss (Biggs Field) in anticipation of the military growth on the Installation. The Post Exchange and

Commissary are going through a remodeling phase if you will, bringing better and newer services to the military community with top of the line retail upgrades, fast food restaurants, state-of-the-art Movie Theater, etc.

We too at the Human Resources Directorate are going through numerous changes. The Fort Bliss Welcome Center has relocated to Building 503, adjacent to Building 500. This building has been completely remodeled and all agencies are up and running, ready to provide the best service possible to incoming Soldiers and Family members arriving at Fort Bliss to include the retiree community. The Post Vehicle Registration Office and El Paso County Tax Office are located in this building, providing post vehicle registration and Texas State license renewals for vehicles. One of the highlights within the Welcome Center is that it is completely handicapped accessible, with an elevator on the A side (rear) and a ramp on the B side (rear) with plenty of handicapped parking spaces between Buildings 500 and 503. In addition to this important upgrade, an ID Card/DEERS Office has been installed on the 3rd floor of the building in order to provide ID Card support for handicapped personnel unable to walk long distances or unable to enter Building 500 due to the size of the wheelchair or scooter. Additionally, the TRICARE Office has also relocated to this new building to assist with TRICARE issues.

Recently, the Retirement Services Office has received numerous calls and or visits from retirees or Family members requesting a copy of their most recent 1099-R (Retiree Tax Statement). Unfortunately, this office no longer has the capability of printing the tax statement from the HUNT-DRAS System. We are able to go into the system and update your retiree pay account so that a replacement tax statement can be mailed to you. Retirees or annuitants can also call toll free to DFAS at 1-800-321-1080 and request it that way. Bottom line here is that retirees should not wait too long before inquiring about their retiree or annuitant tax statements, if it doesn't arrive at your address by the middle of January, please contact us for assistance. One other option is by accessing DFAS on line through myPay; however, if the retiree does not keep the myPay account active it will not allow access to tax forms or any other services.

The Fort Bliss Retirement Services Office is currently in the process of preparing a Personal Affairs Guide Book for Widows and should be completed in the next couple of months. This guide book will be tailored to the needs of the local retiree community. In the past six months, this office has provided assistance to hundreds of military widows and survivors, preparing applications for Arrears of Pay (AOP) and Verification for Survivor Annuity (SBP) payments. This process is sometimes hampered in that widows and survivors are misinformed as to what needs to be done and in what order upon a retiree's or annuitant's death. Some contact the Veterans Administration, local veterans organizations, DFAS, ID Card/DEERS, Social Security or the RSO making for delays in benefits and payments due. This office is readily available to assist in the notification process starting with DFAS, Social Security, Veterans Administration, Civil Service Retirements and insurance companies too. Bottom line, when a retiree or annuitant passes, contact the Retirement Services Office, we will make notification, verify entitlements to AOP and SBP Annuity payments and ensure that a new dependent ID Card is reissued due to changes in sponsor's status. We will also assist in contacting other offices relative to retirement or death benefits.

We remind the military retiree community of other services available at the Fort Bliss RSO such as assistance with changes to retiree pay accounts for allotments, beneficiaries, mailing address, financial institution, tax filing and withholding status and assistance in requesting 1099-R forms and Retired Account Statements. This includes assistance in obtaining copies of lost documents (i.e. DD 214, retirement orders, medical records, etc.)

As always, the Fort Bliss Retirement Services Office is ready to provide our local military retiree community (for all services) assistance in any postretirement services required. Mr. Walter R. Basil, SBP Counselor and I are here to serve you - the retiree, Family member and widow.

Unlike previous campaigns, this year's effort will emphasize paid memberships. The "double~down" recruiting incentive is back again this year, with chapters receiving \$20 for each paid membership. When the campaign ends Dec. 31, 2010, the chapter with the most paid memberships [minimum of 10 paid members) in each of 10 categories based on chapter size will receive \$1,000.

Each quarter, a \$500 bonus will be given to the council in each of four regions that adds the most paid MOAA memberships (minimum of 10 paid members). However, a council cannot win in two consecutive quarters. An independent chapter in each region, which is not served by a state council, will receive \$250 for the most paid members. Quarterly bonuses will be paid only if an independent chapter has recruited a minimum of four new paid members, and an independent chapter can't win in two consecutive quarters, Finally, councils that have 75 percent or more of their chapters recruit eight or more new paid members will earn, "A Night Out With MOAA" incentive.

THE BORDER BULLETIN Legislative John B. McKinney

John B. McKinney - Legislative Chairman



The Second Session of the 111th Congress has started but little legislative action has taken place. Initial work was stopped due to the record snowfall in D.C. followed by the President's Day recess. While Congress is now back at

work the recently presented President's budget for Fiscal Year 2011 is commanding attention as is the continuing issue of national health care. The former included remarks that the President wanted to look to the future beginning in Fiscal Year 2012 and hold discretionary funding to a 3-year freeze in an attempt to reduce the federal deficit (the difference between what the government spends and what it takes in). The federal debt is the total amount the government owes to its lenders (China and Japan are among the largest). While the VA has been receiving significant annual increases in its health care budget, this is a discretionary account; benefits and the national cemetery system are mandatory accounts. Where this goes remains to be seen.

MOAA has developed its 2010 federal legislative These were enumerated in the January issue of the MOAA magazine but I'll repeat them for emphasis. The primary goals are: 1) Reverse Medicare/Tricare payment cuts; 2) Sustain people and weapons in the defense budget; 3) Sustain military manpower increases; 4) Gain wounded warrior and caregiver fixes; 5) Resist shifting health care costs to beneficiaries (the Secretary of Defense is outspoken on this issue saying that beneficiaries need to pay more for their military provided health care); 6) Repeal the SBP/DIC offset; 7) Work for full concurrent receipt with emphasis on phasing out the retired pay offset for Chapter 61 retirees; 8) Restore military pay compatibility; 9)Upgrade the Guard and Reserve retirement health care programs; and, 10) Improve spouse and family support. are ambitious but demand attention. The lobbying issue is one of trying to convince legislators to incorporate our priorities into legislation, primarily the budget, while also listening to other lobbyists and constituents. The latter are key to trying to convince legislators how and what to vote on as they are dependent on constituent votes to get elected or reelected. Telephone calls and e-mails are the best way to communicate with legislators, at least those in Washington. Letters take time to reach individual offices and can take as long as two to three months.

While not legislative in nature, something that needs to be closely watched is the recently appointed Debt Commission. Created by Presidential Executive Order since the concept was voted down by the Senate, the commission is tasked with making recommendations to Congress to reduce the federal deficit to 10% of the Gross National Product by 2015. Key to the committee are the individuals appointed to it; while bi-partisan in nature one already appointed is the head of a large union who sits in on cabinetlevel White House meetings. One committee cochair sat on a similar committee in 1994-95 which recommended that COLAs be limited when applied to Social Security and military and federal retirement benefits.


Commission recommendations are not binding, which is why the Senate voted down the initial concept as it made all recommendations part of a total package to be voted "Yea" or "Ney" much like BRAC recommendations. Of concern is that all government programs, including VA health care, military retirement, Social Security and Medicare, are subject to being looked at. Final committee recommendations are due the end of 2010. This means they will be taken before the 112th Congress (2011-1012) for consideration.

For those members who have claims pending for service-connected disabilities Congress has approved over the past 2 years funds for the VA to hire additional claims raters and adjudicators to help bring down the claims backlog. It takes 2-5 years to train new people in these positions and progress slows down in the interim as experienced people must train the new ones. The concept is great but results can be slow in coming. The regional office which handles the claims for the El Paso area will be going to double shifts. Part of the reason for this is that while funds have been made available to hire new people, funds for expanded physical space have not kept up. Paper claims files have been relocated from the regional office building to an offsite location to free up office space. This adds to the processing time.



Chapter Bylaw Changes

The below recommended changes to the chapter bylaws were agreed upon by the Board and are now presented to the Chapter Membership for approval at the April 10, 2010 Membership Meeting and Luncheon.

Article IV membership Section 5(Change 1st Sentence to read) "Chapter members will hold and maintain membership in MOAA National."

Article VI - Dues Section 1

Append "Section 1.1 At the discretion of a majority of voting Officers, Directors, and Chapter Staff Emeritus, online credit card processing may be implemented for the payment of membership dues, event registrations, and monetary donations to the chapter."

Section 2 - (Change to read)

"The annual dues for a calendar year will become due in the anniversary month (12 months) of the prior year payment. Pending member dues notification will occur not later than 30 days prior to the anniversary month."

Section 3 - (Modify first sentence to read) "Members who become 60 days delinquent paying dues shall be notified of the delinquency by email and/or postcard.

Section 5 (Amend the 6th Sentence to read) "At the beginning of each calendar year, The Treasure may transfer from each Life Member's account an amount to be determined by the Board to the Chapter's operating fund, as needed form a separate account set aside to maintain the Life Membership Reserve."

Section 6 - Delete This section relates to prorating chapter dues.

Article IX - Officers Section 2

Append "Section 2.1 The Membership shall indemnify and hold harmless any individual who has served or who is serving as an officer or Board member against claims or liabilities arising from such service, and shall reasonably reimburse expenses incurred in defending against such claims or liabilities, provided they do not arise from negligence or willful misconduct of the officer or Board member."


