
AUGUST GUEST SPEAKER Adair Margo



Adair Margo chaired the President's Committee on the Arts and the Humanities during the two-term presidency of George W. Bush (2000-2008). She joined First Lady Laura Bush in Paris, France for the United States' re-entry into UNESCO and was appointed by Secretary of State, Colin Powell, to the US National Commission of for UNESCO. She received the US Presidential Citizens Medal in 2007 from George W. Bush and the Mexican Aguila Azteca in 2008 from Felipe Calderon for using arts and culture to strengthen relationships between the United States and other nations, beginning with Mexico. She also was recognized as the cultural ambassador of Juarez by Mayor Armando Cabada in 2019 and as Promotora del Ano at Mexico's Tanguis Turistica in 2021 by Manuel Lopez Obrador.

She owned Adair Margo Gallery from 1985-2010 in El Paso, Texas, exhibiting over 400 artists from 12 countries. She became especially devoted to Tom Lea, founding the Tom Lea Institute in 2009 and establishing the Tom Lea Trail, which connects the histories of 19 communities in Texas, New Mexico, and Chihuahua through Tom Lea's art and writing - the first bi-national artist-named trail of its kind in the world. She has authored or contributed to seven books, including the award-winning *Tom Lea, An Oral History* (1995) and *Jose Cisneros, Immigrant Artist* (2006), published by Texas Western Press.

A former First Lady of El Paso, she earned her B.A. in Art History from Vanderbilt University; studied Italian and Renaissance art with Syracuse University in Florence, Italy; and completed her M.A. in Art History from New Mexico State University. She is married to The Honorable Dee Margo and has three children and nine grandchildren. She teaches and writes on the arts, culture and history of the U.S./Mexico border.







Doc's Corner Daniel Washburn, M.D.

It is estimated that up to 70% of people in the U.S. have an eye problem called refractive error that requires the use of a corrective lens to see well. When light rays enter the eye, they are bent by the cornea and lens in the front of the eye to a focus point on the retina in the back of the eye so we can see clearly. However, with refractive error, the focus point lands either in front of or behind the retina and therefore needs correction to move the focus point onto the retina for clear vision.

The three types of refractive error are near-sightedness (myopia), far-sightedness (hyperopia) and astigmatism. All are corrected with lenses.

Although eyeglasses are the most common way to correct refractive error, there are also other options. For young people, Lasik surgery uses a laser to reshape the cornea on the front surface of the eye to permanently treat refractive error so a person can then see clearly without glasses. Cataract surgery also treats refractive error. Although some people still need glasses after cataract surgery, many are much less dependent on their glasses or can even get by without glasses.

Contact lenses are another option for treating refractive error. Most contacts just correct distance vision. However, there are options for also treating near vision. A multifocal lens corrects near and distance vision. Monovision also corrects near and far. This is when the contact lens in one eye is set for distance vision and the other eye is set for near, which then frees a person from any type of glasses.

Again, the most common way to treat refractive error is with eyeglasses. Glasses can be single vision for distance, single vision reading glasses or a combination of distance at the top of the lens and bifocal at the bottom of the lens for up close. The bifocal can be a no line progressive or a lined bifocal. Some people like the cosmetic appearance of a no line bifocal but they are often a little harder to get things into focus with. If prescription lenses for distance vision are not needed, but you need help up close, over-the-counter readers are almost always the best option. They are much less expensive than prescription reading glasses and do the same thing.

Where Could Your COLA Land in 2023?

APRIL 27. 2022

The economic indicator responsible for setting the cost-of-living adjustment (COLA) for military retirees, disabled veterans, Social Security recipients, and others has edged even closer to record-setting territory.

Frequent visitors to MOAA's COLA Watch page won't be surprised by this trend, but new figures point to an even larger adjustment in 2023 to combat ongoing inflation. The March Consumer Price Index for Urban and Clerical Workers (CPI-W), a figure released in April, was 1.52% higher than the February number. It's the largest February-to-March jump for CPI-W since at least 1978, when the statistic underwent a major revision and name change.

While the figures determining the annual COLA won't be set until later in the year – a walkthrough on the math is available at MOAA.org/colawatch – predictions point to a major uptick from last year's 5.9% COLA. The Senior Citizens League, a nonpartisan advocacy group, <u>predicted an 8.9% 2023 COLA increase</u> based on the March data. That's up from the group's 7.6% estimate the previous month.

PACT Act, Offering Comprehensive Toxic Exposure Reform, Clears Major Senate Hurdle JUNE 07, 2022

Decades of grassroots work to reform the VA's practices regarding toxic exposure benefits, months of bipartisan negotiation, and a flurry of late advocacy efforts by MOAA and dozens of other groups have resulted in the largest step forward yet on the path to helping millions of underserved veterans. The Senate voted 86-12 on June 7 to invoke cloture on the Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive Toxics (PACT) Act of 2022, a procedural move allowing for a full Senate vote expected in the coming days. If a majority of senators back the bill in that vote, it will return to the House, where an earlier version passed 256-174 in March.

Total Team Effort': Toxic Exposure Reform Bill Passes Senate, Heads Back to House JUNE 16, 2022

The Senate voted 84-14 on June 16 to pass the Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive Toxics (PACT) Act of 2022, sending the bill back to the House for consideration. The House previously passed a version of the omnibus toxic exposure reform legislation 256-174. While the bill is expected to clear the chamber again, MOAA is asking its members and others to reach out to their representatives and secure their support for expanding VA care to more than 3.5 million veterans, adding 23 ailments to the list of those connected to toxic exposure, funding dozens of new VA facilities in 19 states, and improving toxic exposure-related screening, research, and claims processing.

"This was a total team effort, from the legislative staffs in both chambers to the dozens of advocacy groups on board to the grassroots work put in by thousands of MOAA members," said Lt. Gen. Dana T. Atkins, USAF (Ret), MOAA president and CEO. "Everyone played a role in this success, but we're not done yet – MOAA and our partners will see this through not just the president's signature, but through the implementation process so critical to ensure the earned benefits of millions of veterans."

MOAA has supported multiple attempts at much-needed comprehensive toxic exposure reform, with efforts picking up in recent years. A coalition formed behind the current legislation, to include veterans groups like the Veterans of Foreign Wars, the American Legion, Disabled American Veterans, Wounded Warrior Project, Iraq and Afghanistan Veterans of America, Burn Pits 360, AMVETS, Reserve Organization of America, and Tragedy Assistance Program for Survivors; veterans advocate Jon Stewart; and members of Congress from both parties, including Sen. Jon Tester (D-Mont.), chair of the Senate Committee on Veterans' Affairs, and Sen. Jerry Moran (R-Kan.), the committee's ranking member. "There's absolutely no reason, none, this bill should be a Republican bill or a Democrat bill," Moran said at a June 7 press event held prior to the Senate's initial cloture vote.

Surviving Spouse Corner: 4 Resources for Older Adults

The community of military spouses, encompassing all past and present, is a resilient group of individuals. The ability to change plans in a moment's notice is a skill acquired over years of experience. The other amazing characteristic of military spouses is that we support each other and share tools, benefits, and resources no matter how long we have known each other.

Here are four such resources to consider:

VA Aid and Attendance: Also known as housebound allowance, VA Aid and Attendance might be able to provide a monthly financial benefit to assist with personal care services. Financial and physical considerations need to be investigated. Local veteran services organizations are a great place to get neutral information and support.

Geriatric Care Managers: Hiring these professionals can be an unmatched option of support for seniors who do not have family members close. They are social workers for hire who can be on a retained contract or situational contract in case of emergency needs. Their experience can help you navigate insurance coverage, emergency services, or placement recommendations if you are looking into senior living locations.

Board-Certified Elder Law Attorney: Often attorneys will list that they offer estate and/or elder law specialties. This is an important area in that "what you don't know will hurt you." From 'Pension Poaching' to Elder Fraud, No One Is Immune to Financial Scams

News of scam artists targeting an older veteran unfortunately has become commonplace, with the Federal Trade Commission reporting more than \$66 million in losses from military retirees and veterans reported to the agency in 2020 alone. But a recent public information campaign makes it clear these scammers can go after anyone, including a World War II Navy veteran who spent part of his post-service professional career at the helm of the FBI:

William Webster, who also ran the CIA and is now a 98-year-old retired judge, and his wife were targeted in a lottery scam in 2014, according to an FBI.gov report. When the couple refused to pay the \$50,000 requested by an unknown caller, the scammers threatened violence. He called his old department; the caller's now in prison. "If it can happen to me, it can happen to you," Webster said in the video, released in early May by the FBI.

Along with the elder fraud threats targeted by the FBI campaign, military retirees and veterans face scams specific to their service. The VA last month reported an uptick in "pension poaching," where an individual or organization misrepresents their ability to help a veteran secure VA benefits, or attempts to convince a veteran to transfer their funds or share personal information to secure greater or faster VA compensation

While no two scams are identical, be wary of anyone making the following requests or proposals regarding your veterans benefits:

Claims of "guaranteed" future VA benefits, or a request to provide credit card information before assisting with a VA claim. Accredited VA attorneys and claims agents cannot charge a fee until after a claim decision.

Requests for your eBenefits, VA.gov, or other VA login credentials.

Claims to represent the VA itself or to hold VA accreditation (Check any organization or claims agent against VA's online accreditation database), especially those accompanied by legal threats for non-compliance. Not sure how to proceed, or if you are actually facing a compliance issue? Hang up and call the VA direct at (800) 827-1000.

Suggestions about moving money into or out of specific accounts to allow for benefits eligibility. Remember: If you receive VA benefits after misrepresenting your finances – even at the direction of a third party – you may be liable to repay the benefits to the government.

Report suspected VA-related scams by calling the VA Office of Inspector General at (800) 488-8244. Report other scams at https://reportfraud.ftc.gov or via your local FBI field office.

This Bill Would Support the Families of Deceased, Defrauded Veterans

A bipartisan bill introduced in the Senate on April 5 would ensure families of defrauded veterans receive the benefits owed if the veteran passes away before their case with the VA is resolved.

The Restoring Benefits to Defrauded Veterans Act (S. 3994), sponsored by Sens. Joe Manchin (D-W.Va.) and Tommy Tuberville (R-Ala.) would add language to existing law that would require the VA secretary to pay out these fraud claims to a veteran's estate, a fiduciary who had served the veteran, or "the next inheritor." The House version of the legislation (H.R. 5966) was introduced Nov. 21 by Reps. David Trone (D-Md.) and Tom Emmer (R-Minn.). The claims stem from misuse of benefits by a veteran's fiduciary where the secretary is found to have committed "negligent failure" to "investigate and monitor a fiduciary," according to current law. There were about 12,000 allegations of such fraud from Jan. 1, 2018, to Sept. 30, 2019, according to a VA Office of Inspector General (OIG) report.

While OIG found no "systemic issues" with the VA Fiduciary Program, it did find "instances of significant wait times," including one veteran owed more than \$20,000 in misused funds waiting more than 19 months after the ruling to receive his money.

MOAA supports the measure along with The American Legion, Paralyzed Veterans of America, Veterans of Foreign Wars, and the Wounded Warrior Project. "Unfortunately, thousands of veterans have been victims of fraud and have dealt with a long, drawn out process to ensure they and their families receive their earned payments," Manchin said in a press release announcing the Senate legislation, adding that the bill would "make a simple fix to help these defrauded veterans and their families receive the support they need and deserve."

Tuberville said Americans would "like to believe we live in a country where no one would take advantage of
