

Please be advised that beginning May 3, 2023, federal agencies will only accept Texas driver licenses and identification cards for official federal purposes - including air travel and entering federal facilities - provided the Texas driver license or identification card is marked REAL ID compliant. REAL ID compliance is indicated by a gold circle with an inset star located on the upper right of the driver license or identification card. 



CHAPLAIN CORNER MRS. CONNIE SULLIVAN

Sometimes, some of us wonder why our loving God takes beautiful souls in the early and prime time of their lives. It seems, perhaps, that these special souls are too precious to be here in this life that has turned against God's guidance, principles and concepts (His Commandments).

There is so much evil now that, maybe, there is no place for such wonderful beings here, even though our hearts are broken of no longer having them with us. They are in a place of joy and happiness in the arms of our Eternal Father and in His loving care.

In our August Luncheon, I had the honor of sitting next to Sgt Major Locklear, a kind and very respectful man. In our conversation, he told me that he had been a paratrooper and I told him that my brother had also been one as well and that he died in an accident from a grenade that was thrown to the wrong side where my brother and three other soldiers were going by in a jeep and killed all four of them in Fort Bragg, NC. Sgt Major Locklear then told me of the death of his son in Irag.

A few weeks later, I called him and asked him if I could write an article about his son. He told me that I could but that his wife would be able to give me better details of his son's death. When I met her, Mrs. Carmen Locklear, an absolutely wonderful lady who come to find out we both had so much in common, like our young years living



in the same area of town, was very kind in sharing her son's circumstance of his death.

When Mrs. Locklear described the kind of person her son had been, I was amazed because my

brother had been the same kind of individual, gentle, respectful, a loving brother and a very good and caring son to my parents. Yes, very special souls.

She said her son was also not only kind and respectful, a loving son to his parents too but was especially charitable, benevolent with Christ-like attributes of pure love. Her son, Sgt Velton Locklear III, died in 2006 in Iraq. On his second tour in Iraq, he arrived in Aug 25th 2006 and was killed Sept 23rd.

On that second tour, coming back from a mission, he decided to stay outside to fix the radio of the Humvee for the next group of troops that would be using the vehicle. His Sgt wanted him to come in to the barracks to rest but he wanted to stay and finish fixing the radio for his fellow soldiers that were to use the humbee on the next mission. He stayed outside until 5:00AM.

When he went in the barracks, there was a young soldier who was telling the Sgt. that he didn't want to go on the next mission because he was not feeling well, he was sick.

So Sgt. Locklear told the officers that he would go in his place. In the convoy while riding in the first humbee, the vehicle ran over an IED and he and the driver were killed in the explosion.

The emotional pain and agony of the parents and family, of course, cannot be described. Our organization, MOAA El Paso Chapter have a scholarship in his name.

It is these kind of soldiers that are the heart of our country. Our Heavenly Father knows our heart pains and sorrows; and even though sometimes we doubt, we need to trust in our creator for He and He alone knows why.

Inspite of our afflictions, tribulations and distresses, our faith needs to stay strong because

He is the only one that can sooth and heal that enormous pain; and by remembering that they are in a better place where there is but love and joy, we can have peace and tranquility

in our souls with our Savior's help.



Why Plans to Merge Commissary and Exchange Systems Have Come to a Halt

Although not completely off the table, it appears plans to consolidate the commissary and exchange systems are far more costly than originally expected, according to a new report – one echoing concerns raised by MOAA and other military and veterans groups since early in the merger discussions.

The Aug. 23 report identifies miscalculations from the previous feasibility study and states the plan actually would cost an additional \$1.5 billion. In its conclusion, its authors say DoD now views the initial 2018 case study as "not feasible, and no longer supports consolidation."

MOAA, along with several other military and veteran service organizations, expressed concern with the commissary-exchange merger since it was introduced in 2018. After the case study mentioned above concluded strong support for consolidating the defense resale system, the FY 2020 National Defense Authorization Act (NDAA) included a provision for the Government Accountability Office (GAO) to review DoD's analysis, and the FY 2021 NDAA included requirements for further, expansive reporting.

"MOAA and our many partners have known for years that merging the exchanges and commissaries would reduce the benefits to military families and the quality of service," said MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret). "The previous business case analysis was flawed and documented in a GAO report in April 2020. MOAA remains committed to protecting the commissary and exchange benefit and is encouraged DoD has changed course. We look forward to partnering with the exchanges and commissaries to support outreach on the importance of this benefit to the uniformed community." The GAO report and the updated business case analysis revealed three areas that were miscalculated or not

considered:

The 2018 analysis overstated savings of the cost of goods sold because the amount of overlap between products sold by the Defense Commissary Agency and those sold by the exchanges amounts to less than onethird of the total cost of goods sold. Original estimates for the development of new, common IT systems to operate the consolidated system only included approximately half of the actual costs. Initial reports failed to account for the costs associated with establishing a new headquarters location. In 2019, MOAA and 27 other members of The Military Coalition -- a group of organizations collectively representing nearly 5.5 million members of the military community -- sent a letter to the House and Senate armed service committees to express concern regarding moving too quickly on a commissary-exchange merger, the accuracy of the predicted costs, and the impact on military families if the merger proceeded without further review. We are pleased with the follow-on report and feasibility study which have steered DoD officials in a different direction.

Yes, it's designed to create peace of mind in the future, but filling it out has the benefit of clearing up many present-day financial concerns. Use the workbook to:

- Keep a running tab of automatic payments, including which account the payments come from.
- Track all your investment accounts, retirement funds, and annuities.
- List your credit card information and any other outstanding debts, including active payment plans.
- Put all your insurance information a critical part of financial planning at any stage in one place.
- Turn that messy notepad in your desk

drawer into an easy-to-read resource full of passwords, contact information, and other must-save data.

Having these materials in case of an emergency, or for use by your survivors as part of a comprehensive estate plan, may solve future problems before they happen. It also will allow you to take stock of your current financial situation: Are there dormant accounts you've neglected? Are you making automatic payments for services you don't use? Do you have overlapping insurance products you don't need? Knowing your financial situation is the first step toward improving it. DOC'S CORNER DR. DANIEL WASHBURN.

I attempted to move away from writing about COVID but can't seem to get away from it. Vaccine booster shots recently became available, and a lot of people have asked me if they should get a booster shot or which one to get. So, I think an update on booster shots is pertinent. The following information is based on CDC guidelines as of November 1, 2021.

Your initial COVID vaccine shots are still very effective at preventing severe disease if you come in contact with the virus. However, ongoing research on the disease and treatments has shown that over time, the immune response from the vaccine gradually weakens and becomes less effective at preventing milder forms of the disease. Research has also shown that a vaccine booster shot rejuvenates the immune response and should provide improved protection against the coronavirus including the Delta variant.

Johnson & Johnson: If you received the J&J vaccine, you are older than 18 years and it has been at least 2 months since your vaccine shot, a booster shot is recommended. CDC recommendations do allow for mixing of vaccine types. So, when you get your booster, you are free to choose between J&J, Moderna and Pfizer vaccine shots.

Moderna / Pfizer: If you received the Moderna or Pfizer vaccine and it has been at least 6 months since your second dose, a booster is recommended if you fall into one of the following categories: 65 years or older; 18 years or older and live in a long term care facility such as a nursing home or assisted living; 18 years or older and have an underlying medical condition such as diabetes. heart cancer. disease and many others; 18 years or older and live or work in a high risk setting such as healthcare, police/ education, correction facility, postal service, public transit, grocery store and others. Again, mixing of

vaccine types is approved so if you get a booster, you can choose between any of the 3 types available.

The booster shot is the same as the original vaccine except for Moderna, in which case the booster is half the original dose. Therefore, risks and side effects are the same for the booster as with the initial vaccine. If you have received the J&J or both doses of the Moderna/Pfizer vaccine, you are still considered fully vaccinated regardless of whether you choose to get the booster or not.

If you go in to get a booster shot, remember to take your vaccine card with you. Also, if you are traveling for the Holidays or otherwise, remember to take your vaccine card with you. Some parts of the country require proof of vaccination to attend public events.

The September 2021 CPI is 269.086, 6.2 percent above the FY 2021 COLA baseline. The average of the July, August, and September CPI figures is 268.421, a 5.9 percent increase. This figure is used to determine the annual adjustment to military retirement pay, Social Security, and other allotments.

The Consumer Price Index for October, the first of the new fiscal year, is scheduled to be released Nov. 10. The CPI baseline for FY 2021 is 253.412; the CPI baseline for FY 2022 will be 268.421.
